**Program:** Officer Eric Kessler, Montgomery City Animal Control Officer came to discuss the new Montgomery **City** Ordinances recently passed:

- Dogs in vehicles must be enclosed.
- Dogs must always be on a leash and the leash can be no longer than 10' in length. Being voice controlled or on a heel without a lead is not adequate.
- The time for resolving a nuisance (barking, smell, defecating on other property, damage, etc) was changed from 15 days to 7 days.
- Took away the "two bite" rule that used to exist. A dog can be declared vicious for one incident of attacking a person, pet or livestock.
- No more warnings will be issued for unrestrained dogs. Tickets will be issued as follows - \$25 1<sup>st</sup> incident, \$75 2<sup>nd</sup> incident, \$125 for each subsequent.
- Owners with dogs tied/chained out on less than a 10' length can be cited for Cruelty to Animals.
- There are NO breed specific laws and no limit to the number of animals someone can have.

## **Constitution**

### Article II

#### Section 2: Dues

Membership dues shall be set each year by the Board of Directors. Dues are payable on or before the first day of November each year. There will be a \$5.00 late penalty assessed for dues over 60 days late. No member may vote whose dues are not paid for the current year. During the month of September, the Secretary shall notify each member that dues are payable for the ensuing year. Each member shall receive a membership card after dues are paid.

### Article V

#### Section 2: Annual Meeting

The meeting shall be held in the month of September, at which time directors and officers for the ensuing year shall be elected by secret, written ballot from among those nominated in accordance with Section 5 of this article. The four offices shall be voted on first and in single order. Those members elected shall take office the first meeting in the month of November, following election in September and each retiring officer shall turn over to his successor in office all properties and records relating to that office within 30 days after the election.

#### Section 3: Proxies

Proxy voting will not be permitted at any club meeting or election.

#### Section 4: Election

The nominated candidate receiving the majority number of votes cast for each office shall be declared elected. When there are more than two candidates for the same office and none received a majority on the 1<sup>st</sup> ballot, the two receiving the most votes will be the candidates on the 2<sup>nd</sup> ballot. The five nominated candidates for other positions on the board who received the greatest number of votes cast for such positions shall be declared elected.

#### Section 5: Nominations

No person may be a candidate in a club election who has not been elected. During the month of June, the Board shall select a Nominating Committee consisting of five members and two alternates, not more than one of whom may be a member of the Board. The Board shall name a Committee Chairman and it shall be his duty to call a committee meeting, which shall be held on or before July 15.

- a. The committee shall nominate one candidate for each office and position on the Board and, after securing the consent of each person so nominated, shall immediately report their nominations to the Secretary in writing.
- b. The Secretary shall at least two weeks before the August meeting notify each member in writing of the candidates so nominated.
- c. Additional nominations may be made at the August meeting by any member in attendance provided the person nominated does not decline when his/her name is proposed and provided further, that if the proposed candidate is not in attendance at this meeting, his/her proposer shall present to the Secretary a written statement from the proposed Candidate signifying his/her willingness to be a candidate. The additional nominations which are provided for herein may be made from those members who were not nominated by the Nominating Committee or who declined such nomination as above provided.
- d. Nominations can not be made at the Annual meeting or in any manner other than as provided in this Section.

#### By-Laws

3. Nominating Committee shall act as teller at all election and count the votes. Any member of the Nominating Committee, who is nominated and accepts, shall be replaced.
7. In order to vote at a general election, a member must attend four meeting a year.
