#### HANDLER DISCRIMINATION CLASSES

**Handler Discrimination** classes are titling classes in which the targeted scent is that of the handler themselves. Handlers are required to provide their own scented articles in a plastic bag: Novice class, one cotton glove or cotton sock; Advanced, Excellent, and Master, cotton balls or cotton swabs. Three qualifying scores are required to earn titles in each class.

#### **DOGS ELIGIBLE TO ENTER**

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered to compete.

**Condition of the Dog.** Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind can participate provided the handler is always in control of the dog, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

#### **ENTRY AND FEES**

Entry must be made on an approved AKC Entry form signed by the dog's owner(s) or authorized agent. Entry fees are \$25.00 per each entry. An entry is defined as a single run by a single dog, in a single class. We ask that envelopes contain entries for only one dog/one handler, but you may include separate envelopes within one bulk mailer. Entry fees include a \$3.50 per run AKC recording fee. Checks returned by the bank do not constitute a valid entry fee and a \$25.00 collection fee will be charged to the amount of any returned check.

#### WAIT LIST INFORMATION

The Montgomery Kennel Club, Inc. is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 25 entries per day will be placed on the club's wait list. Wait list info will be posted on the club's website, <a href="www.montgomerykennelclub.org">www.montgomerykennelclub.org</a> and it is the responsibility of the entrant to monitor their progression on this list. All entries, including wait listed entries, must be received by the Trial Secretary prior to February 1, 2023. No entries may be withdrawn with a refund after closing on February 1, 2023. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry after a \$10.00 processing fee is deducted. Any wait listed entry that does not move off the wait list into the trial will receive a full refund. Pre-Trial Wait list entry changes will end on Wednesday, February 8, 2023 at Noon CST.

#### STAGING AREA, HANDLERS' BRIEFING, AND WARM-UP INFORMATION

**Staging Area(s)** will be out of view of search area(s). Staging area(s) will include crating, warm-up and waiting areas, as well as the secretary table for check-ins and posting of running order and results.

The **Handlers' Briefing** will take place prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. The Handlers' Briefing may or may not take place in view of search areas and will follow applicable Covid-19 restrictions. During the Handlers' Briefing the judge will explain if there will be any off-leash option, number of hides, maximum height of hides and maximum time for the search. **No dogs are to be present during the Handler's Briefing.** 

The club will designate a **warm-up area**. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

#### SEARCH AREA AND SEARCH CONDITIONS

**Search Area Conditions:** Searches may be indoors, on matted, carpeted, or tiled/concrete surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

**Search Area Sizes:** Search areas may be of any shape and of the size specified as required in the *Regulations for AKC Scent Work.* 

#### **ADDITIONAL SITE INFORMATION**

**Trial Site.** It is not appropriate to scout the trial location prior to the trial date. Montgomery Motor Speedway regularly hosts auto racing events and is a "real life environment." Visiting when the track is not operational may risk the host losing the opportunity to use the location in the future.

**Possession of Odors and Training**. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area."

**Spectator Area.** Spectators are allowed, but judges reserve the right to request a change to this policy. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes

**Parking.** Please be mindful of all parking directions and signage. All parking will be on the grass. Please be respectful of the facility and ensure all trash is disposed of appropriately.

**No interior crating space will be available.** Entrants are encouraged to crate inside their vehicles. Dry camping is permitted. Crates, canopies, etc. may be left overnight; however, the Montgomery Kennel Club, Inc., nor the Montgomery Motor Speedway will be responsible for any lost or damaged items left at the show site.

**Exhibitors are responsible for cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

#### **VOLUNTEERS**

No trial is possible without volunteers. If you would like to volunteer at this trial, please complete the included volunteer form and mark "volunteer" on the outside of your entry envelope. Approved volunteers (up to 10 spots) will receive priority entry to the trial drawing and volunteers will run first during searches. Lunch will be provided for volunteers who help with the trial a minimum of four hours each day that they help. You do not have to be entered in the trial to volunteer and can also do so on the www.montgomerykennelclub.org website... Click on "Volunteer with the MKC".

#### RIBBONS, ROSETTES, AND THE POSTING OF PRELIMINARY RESULTS

**Placement rosettes** will be awarded in each class as follows: First Place—Blue, Second Place—Red, Third Place—Yellow, & Fourth Place—White

**Qualifying Scores** earn a dark green flat ribbon. A New Title rosette will be awarded to all dog and handler teams finishing a title. Please let the Trial Secretary know when you enter if you will be earning an Elite Level Title at this trial.

**Posting of Preliminary Results** Per AKC guidelines, we will post preliminary results, based on the secretary's entry of the judges' score sheets, and have qualifying and placement ribbons made available. If placements change after the judges review the recording of scores, neither the judges nor the scent work committee have an obligation to inform exhibitors. Final results will be emailed to participants following the completion of all trial recordings. No awards will be mailed.

#### **AKC SCENT WORK REGULATIONS**

#### SAFETY, BEHAVIOR, LIABILITY AND OTHER POLICIES

**SAFETY, BEHAVIOR and LIABILITY**. The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that **exhibitors alone are responsible for the behavior of their dogs and/or children**. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club, the Montgomery Kennel Club, Inc., the Montgomery Motor Speedway, and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club and the Montgomery Kennel Club, Inc. reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club, the Montgomery Kennel Club, Inc., or Montgomery Motor Speedway or any official thereof.

**Collars, Leashes and Harnesses.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

Dog Policies. All dogs must be always on leash, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must stay in designated areas to avoid contaminating testing space, interrupting, or viewing any part of the testing. Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed. No dogs may be left on the trial premises unattended overnight.

#### **REFUNDS**

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical conditions are not eligible for a refund. **Bitches in season** may not run and will be refunded the full entry fee provided notification, in writing, is given to the Trial Secretary no later than one half hour prior to the start of the first class of the day of the trial.

#### **NOTICE TO EXHIBITORS – PLEASE READ**

Judges are not required to wait for dogs; the Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Dogs MAY be moved out of order to facilitate a speedy trial.

We will be using the AGILITY GATE or REMIND app (TBD) during this event. Instructions how this will be used at the trials will be emailed to all participants upon confirmation of your entry.

**EXHIBITOR CHECK-IN**: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email. **Exhibitors MUST check-in EACH day** they are entered at least 30 minutes prior to the start of their first class.

CLAIMS. Claims will be arbitrated as set forth on the Official AKC Entry Form Agreement for this event.

**HEALTH INFO**. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**HANDLING MORE THAN ONE DOG** Handlers may not handle more than one dog in each class except for the Handler Discrimination classes. Multiple dogs from the same owner may be entered in the same class provided they are run by different handlers. Novice A and Novice B are different sections of the same class. (AKC Scent Work Regulations Chapter 2, Sections 10 & 11.)

**COVID STATEMENT**: Participants are expected to follow state, local government, facility, and event guidelines regarding COVID-19. Please check the CDC (<a href="www.cdc.gov">www.cdc.gov</a>) and AKC Scent Work websites (<a href="www.akc.org/sports/akc-scent-work">www.akc.org/sports/akc-scent-work</a>) for their most up to date information. Specific procedures consistent with the CDC, other governmental directives, and/or AKC guidelines may be implemented at the discretion of the Trial Committee. These may or may not be fully known by closing. Exhibitors will be notified, if possible, prior to the trial.
